Governing Document Rewrite

The July 31, 2021 Q&A meeting is postponed. As a homeowner, you are aware that the new governing documents for Northmoor Acres are in FINAL draft form and these drafts are available on www.northmooracres.com under Announcements. The original documents are outdated at 40 years old even with some amendments over the years. As you are also aware, Northmoor Acres is run by a homeowner's association (HOA) and Board of Directors. The governing documents specify the Board's authority and obligations, define the rights and responsibilities of Association homeowners and overall are very important to the workings of the HOA.

A Homeowners' Association is created by filing **Articles of Incorporation** for a nonprofit organization with the secretary of state where the development is located. For Northmoor Acres, that is Colorado. The articles are usually brief and contain only the basic information about the Association - its name, location, and purpose.

Once formed, an Association adopts a set of **Bylaws** which are important because they describe how the HOA is run. The Bylaws establish such things as voting rights and procedures, rules for how to call a meeting and how often meetings are held, and lay out procedures for creating the annual budget and determining assessment amounts, to name a few.

The *Declaration of Covenants, Conditions and Restrictions (CC&Rs)* are the "King" of governing documents. They contain the most comprehensive information about the development and its operation. If there is anything in another governing document that conflicts with a provision of the CC&Rs, the CC&Rs are the controlling document. Every homeowner must abide by all the rules, restrictions, terms, and conditions found in the CC&Rs, and courts assume that an owner has knowledge of the covenants as a matter of law because they are in the "chain of title" and attach to the property.

NEW Dog Waste Bags and Garbage Cans

You may have noticed newly installed dog waste bags and garbage can stations at our Greenbelt access areas. A big thanks to our neighborhood girl scout, Jessica Balderson, for making this happen. Jessica will be maintaining these stations as part of her duties. Upon her project completion, the Greenbelt committee has committed to continuing the operations and maintenance of the stations. Thanks again to Jessica and everyone who has helped get them installed.

Volunteers Needed - Committee Sign-Ups

There are several committees for which you can sign-up and participate for the benefit of the neighborhood.

Covenant Control Committee (CCC) - The Board has created this committee for the purpose of monitoring covenant compliance, reporting violations and recommending corrective actions to the Board. The goals and objectives include but are not limited to:

- 1. Oversee the enforcement of covenants
- 2. Provide a fair, consistent and efficient way of enforcing covenants
- 3. Oversee and be responsible for following through on covenant violations
